YOUR VEHICLE MUST BE AT A QUALIFIED REPAIR CENTER TO OBTAIN AN AUTHORIZATION. THE FACILITY MUST FAX AUTO PROTEC A WRITTEN ESTIMATE FOR REPAIR TO 864-963-7341. AUTO PROTEC WILL RESPOND WITH AN APPROVAL FOR REPAIRS WITHIN 24 HOURS. A.P.
